From Breaking Laws to Making Laws: Insights from a Former 'Juvenile Delinquent,' Now a Juvenile Justice Attorney

A juvenile justice attorney at the National Center for Youth Law in Oakland, CA, Frankie Guzman is working to reduce prosecuting and incarcerating children in California's adult criminal justice system, and advocating for alternative sentencing and local treatment. Guzman, incarcerated as a teen, went on to become a community college transfer student to UC Berkeley and graduate of the UCLA School of Law with a specialization in Public Interest Law and Policy. Today, Guzman is an expert in juvenile law and policy and is a co-author of numerous juvenile justice laws, including California's Proposition 57 passed in 2016 in partnership with the Office of Governor Jerry Brown. 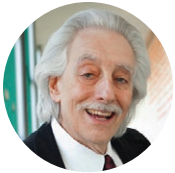


APPROACHES TO ALLEVIATING HOMELESSNESS
