This included eliminating the group airfare reservations and allowing students to book their own flights. Issues about student booked flights such as delayed flights, late arrivals, students backing out at the last minute due to no flights or high cost flights were discussed. Delphine Broccard is continuing to actively recruit and two more info sessions are scheduled for next week.

## II. **Global Research Symposium Spring 2019**

Delphine Broccard provided an update on the Global Citizenship Symposium scheduled for May 2019. She has been to the Phi Theta Kappa (PTK) meeting to speak about the Symposium. Many current students in PTK are past recipients of GC Symposium scholarships. Alexandra Tower will speak about the Symposium at the next Department Chairs meeting.

## III. 2019-2020 Global Citizenship Theme

The committee discussed the possibility of keeping the current theme, Justice, for a second year in 2019-2020. The theme is very timely and is promoted in the GC Symposium and in Global Grants. The Committee would like to get more departments on campus interested in incorporating the theme in their course work. Pete Morris suggested using Flex Day to promote the theme. The Committee also discussed adopting all GC themes for 2 year periods going forward.
