### IX. Discussion Item

**9.1** Alternative options for Funding Classes.

Summary: Sheet created by Jasmine D. Don't have temporary options on this sheet as pointed out by David. Salary cuts not the best option, might not make SMC the best place, could encourage staff to leave according to DJ. Are we supposed to ask professor's to cut their salaries? DJ saying that there are contradictions to Harrison's argument. David agrees with DJ, Trustees are looking at short and long term measures. We want to give Trustees options to look at. Agree that every point DJ is making is astute and might have repercussions, five year plan way to go, tired of contract education and want to talk about what AS can do. William agrees with DJ and David. Want to ask them to cut money because think they make too much, they have their own families and it isn't the way to go. Joshua says this is not finding a solution. Is a gesture of unity but nothing we could coerce professors to do. Have presented this option to the Board of Trustees but it is just as unsustainable as contract education. David wants us to discuss long term AS options an actual plan about how we can make a difference. SMC have a huge capital budget but can use those for operating funds. Contract out bond money and goes to contractors. Proposal from audience member is that companies SMC does business should use some of that money to make classes for training purposes. Jasmine D. brought a page she referenced for her sheet. Point of people making more money is that is gives them an incentive, need to give more pay to positions that are higher and do more. David says what DJ is referencing is management theory. SMC gets revenue from F-1 visa students and SMC can use that for anything. President Tsang uses that and we need him to tell us what it is for, a total of \$24 million dollars. Need to know figures about how much it costs to run a class etc. Marco suggests increasing class size limit, increasing distance education classes. Having two dates for enrollment could be more equitable, two classes per enrollment. DJ says that we can't account for what the \$24 million is spent goes into the budget. Need to talk about a solution that won't take from our own campus. Need to bring in money to campus. David wants to integrate the student body, opt out mailing list for student body. Need to integrate community, such as businesses in Santa Monica. Business networks that we go to business for over and over. Need to mobilize community. Dean Hearn's concerns are that we don't want the Board to waste time and spend energy in vain. It is critical that the next Board be involved. This is a challenge because everyone is at different levels of information. Everyone has the responsibility to check information. Need information in order to move forward. Need to sit down with faculty, staff, administrators, etc before decisions are made. Distance education could work but talks of low retention. Maybe make list of questions we need to know and need to be answered.
