### VII. Action Items

7.1. Approval amendment on Fiscal policy

To change the language of section 1.1 <u>Disclaimer</u> to "The Board of Directors may approve expenditures necessary for the operation of the Board of Directors or the Student Life Office (e.g., conferences, retreats, office equipment, etc.) without following the proposal process set forth in this Fiscal Policy"

To change the language of section 4.6 <u>How to submit a proposal</u> to "Proposals that will benefit <del>a small number of</del> students, such as fieldtrips or scholarships, must include a list of students with their SMC ID and current A.S. sticker numbers when submitting a requisition for the funds, if approved, for the A.S. membership verification"

To add in section 5B After completing the project to "1. After an off-campus project **and A.S. funded field trips** is completed, the project proponents must provide the Associated Students with a short verbal report during the A.S. Board and ICC meetings. Also, photos or videos should be submitted to the Director of Publicity for the use on the A.S. website. All reports must show the benefits of the A.S. funding for the student body.

- 1. All the report materials must be presented within three weeks after the completion of the project **or fieldtrip**. The A.S. Secretary must be notified first of when the presentation is to be made.
- 2. If the project **or fieldtrip** is not planned to be completed in the semester it is funded, a progress report must be made at the A.S. Board meeting during one of the last four meetings in the semester. The progress report must be made every semester until the completion of the project **or fieldtrip**."

To add in section 6B Campus Events 1. The event must be Zero-waste compliant and use

**Mohammad:** Conference was a good experience, spent a lot of time with the board, got some socializing/communication skills. Networked. Conference was educating. Look forward to implementing what I learned the rest of the year. Homecoming: Game is on Saturday from 1-4pm. Working on homecoming spirit week. First 200 people to show up get a free \$5 voucher for food. There will be an after party on the northwest side of the football field, near the ticket booth. There will also a drawing for an iPad. AS Board, athletes, and Alumni are invited.

London: Spreadsheet completed for the most part. There are some gaps in locations for meeting places for some committees. ## X. Discussion Items

10.1. Director's Committees (London)—If you look in your bylaws, there's a committee specific to each position. People have not been sitting on their committees. Going to send an email saying who should sit on what committee. If you can't make that, have a commissioner do it. You don't want to be impeached for not following through with the bylaws.

Parker: How can we get a report from the students who are sitting on the committees? Students sitting should talk about what's happening.

London: Students taking turns e-mailing all the chairs of committees to get minutes from each of them. Student reps shouldn't really take notes; get them from secretaries since that's their job/focus. Get all info from the students and report.

Parker: They should still take notes since they get paid to do so. Designate someone to come here and give a public comment on it.

London: The person who took the last notes of the meeting. Notes should be submitted by the end of the month. What can I do to save time? If I go through multiple committees and notes. Parker: Make it aware that you can't just show up and zone out. If you're not going to do that, you should not be there. We can work something out where someone gives information. A little loose in the sense that we can have London be the one to make these rules. He's the rule maker so he can set things up. This is huge. The committees are really important. That way things can be more democratic and it's not authoritarian.

London: (As far as past committee meetings) Whatever happened in the past, it doesn't matter. We'll try to work out a system. Try to take notes during meetings.

Yacob: Do we still have to turn in our notes? Or are our reports enough?

Parker: We should dedicate parts of our director's reports to the committees

Dean Hearn: We need to see them at least once a semester. At least in the middle of each semester to tell them what we want from them and see what they're doing.

London: How are we going to put that on the agenda?

Parker: We can put it as guest speaker
