VII. Action Items

7.1. AS Director's right to be included in all AS Board related meetings (Yacob) Motion by Mohammad, Seconded

Yacob: Last Monday after the Board meeting, there was the first Publicity committee meeting. Was told he was unable to sit in the committee meeting because he wasn't a member. Any director has the right to sit on any committee.

Cécile: Aren't all committees open to the public?

Parker: Yes.

Michelle: What about standing committees? **Parker**: They must be open to the public.

Jesse: As a director, I try to make all the right decisions, but that doesn't always happen. We just feel the meeting would run more smoothly without distractions. Our board is 8 members. We *are* a large board and are have very diverse opinions. All AS Directors' opinions count because it has to go through the Board meetings. Yacob, I don't know where we went wrong but I apologize to you for whatever I did.

Yacob: The meeting started and I was told I was not allowed to sit at the committee. It's not personal, I just want to make sure nothing like this ever happens again.

Jesse: I don't think that I did anything wrong. I let people know in advance and I asked for everyone's availability. I'm not trying to have people against me, and it doesn't feel like people are working with me.

Call to question by **Faheem**; vote taken. 7 in favor, 2 opposed

Motion passes.

Parker: Clarification on this. This doesn't mean that directors not in the committee have the right to speak. They do have the right to observe.

7.3 Resolution (Michelle)

Michelle: Reason for putting this forth is because it's kind of urgent to get the wheels rolling this week. The college is looking at other people from the community, benefactors. We really do need something like this. Their funds would be generously appreciated.

Parker: I think this is a great idea, but there shouldn't be 8 whereases, only 4.

Michelle: There is a possibility that the community could match whatever we fundraise.

Parker: If we do adopt this, we would have to make some amendments. There is still a possibility that there could be a Winter session. The AS could be a part of this. I like the wording of the last part because sometimes it's good that we leave it a little vague; we can't promise a winter.

Spin: That's a winter session for 2013?

Michelle: Yes

Spin: I hate to be a Debby downer but it's terribly ambitious to do this right before the holidays.

Cécile: Michelle, do you have numbers?

Michelle: Pasadena City College fundraised 200,000 within a couple weeks.

Cécile: In the past, people have said we have a certain amount in the reserve.

Michelle: We're not planning on using AS funds, unless there is a possibility to use some to generate more. Deirdre Weaver has a database with about 300,000 people. If we asked for \$10 from past alumni, \$1 or \$2 from students, we could meet goals.

Parker: What do you have in mind?

Michelle: I'm waiting on PCC's Student Trustee and she's going to let me know what they did. After seeing you do Prop 30, I see that you can do something. This would be almost another Prop 30 campaign.
