8.1. Approval of funding for **Psychology Department/Psychology Club Members** for present research conducted by SMC Students and faculty at WPA. This includes Siena Hotel, WPA Conference registration fees, WPA member application, Hertz rental car and gas costs, and \$25.00 from 5 students and 1 advisor each. (Narhyn, Student Success: \$2,163.37)

Narhyn: This is part of the research group here, and we also overlap with Psych club.

Aaron: This is a whole separate issue from Dept. and Psych club. There just happens to be overlap. It's letting people know that even at a community college, we're still doing research.

Tatiana: Everyone going on the trip is going to contribute \$25, including advisors. **Jemal**: Thank you for doing this. It's nice to see people doing things for research.

Major action item approved unanimously.

8.2. Approval of funding for **Internship Program of the Career Services Center** for Internship Fair. This includes Del Rey Party Rentals, 162 chairs, 75 table cloths, campus kitchen breakfast and banner update. (Judy, Special Projects: \$2,437.04)

Annual event, done every spring; draws about 2,000 people.

Jemal: what subjects are the internships going to cover?

Judy: all types! Most are not paid.

Jon: Could we have a booth for the AS?

Judy: Yes.

Major action item approved unanimously.

This includes hotel, bus, chips and one overnight stay in SD. First come, first serve.

Open to other students outside of the club. Two day, one night trip.

Major action item approved unanimously.

Approval of funding for Future Alumni Club/ Future Alumni Club to activate our network, creating an event in celebration of students who are transferring, and to gather student information to further develop the Alumni program. This includes food, banners and games. (Alex, Special Project: up to \$1190.00, ICC allotment \$170.00)

The intent for the event is threefold: 1-celebration for those who are going to graduate and move on, 2-data retrieval to keep students in the loop, 3-generate some wow-factor with PR. The bungee jump, etc, are intended to add a wow factor to the event.
