## VII. Action Items

7.1. Approval to support resolution requesting that Santa Monica College approve In-state fees for all Military Veterans (Jesse)

Motioned by Faheem, Seconded by Erin

Jesse: Adding on to what Shaphan, the president of the Student Vets Club said, show support of bills that allow in-state tuition for all military veterans that serve our country.

Spin: When it comes to different GI Bills, based on a period of time. Can activate it for a certain period of time. If he starts using it now, will cover the most expensive public school in the state tuition.

Shaphan: They cover instate and veterans have to cover all other expenses. Biggest thing trying to push is to allow veterans to come to this college. There are many "veteran friendly" colleges and others that will end up passing the bill to be "veteran friendly." Think that Santa Monica College because of the great community. They will pay up to that but not exceeding that amount. Preemptively support this bill

Spin: If veterans can come here without using the GI bill, when they transfer they can then activate the GI bill and not have problems affording the costs of those schools since those schools are higher.

Parker: All veterans if they come to CA would be considered

Shaphan: Within a certain time frame, often 12 months. Can't come 10 years later and then get instate tuition because then at that point it would seemingly appear that they had chosen another state and could be unfair.

Parker: Currently a bill in the assembly?

Shaphan: S. 257. Newer bill that is passing through the assembly currently, "Less aggressive" and doesn't necessarily force schools into doing things (and where if hey don't, they get penalized)

Parker: [Reads Jesse's resolution]. Our board would be taking a stand on it; measure of solidarity. Resolution is worded oddly at some points and there is incorrect information within the resolution.

John Fraser: Important part is looking at the actually resolution and what you're doing. Other things can be changed at a later change

Dean Hearn: Clarification on the bill. Particular resolution, trying to get veterans coming to California to get instate tuition to all community colleges or just SMC

Shaphan: At this point, preemptively doing it just at SMC right now. Will eventually be a nationwide thing

Yacob: Point of doing this now when it will eventually pass? Makes more sense to have the college to just support the bill since it is difficult to get the college to just fund something like a garden.

Parker: Add a line in the resolution showing the support for the bill?

Parker: S. 257 is federal legislation. At this point, we would be supporting the resolution. Add a second resolve that says "Resolved; the Associated Students supports S. 257." Is there any more discussion on the resolution? Would just be taking a stance to on the resolution.

Dean Hearn: How soon does this need to be approved? Can this be done at the next meeting.

Would hate to have the board feel rushed on something that they are not

Yacob: Could also work on fine tuning the resolution.

Jemal: Motion to postpone this action item until next week, Mohammad

No objection – Action item is postponed to next meeting

## 7.2. Approval to support resolution for men's self-defense class (Parker)

Motioned by Mohammad, Seconded by Faheem

Parker: Came up originally at the beginning of the year by Jesse. Perfectly okay with a women's self defense class but want to offer a similar class for men if the women's class cannot be co-ed. Reality is that men also experience violence. Support the idea of having a new co-ed class or simply an all men's class.

Jesse: Current professor encourages men to be a part of the class and learn about defense in a friendly environment. Should offer a class with the same ideology of the women's class and learn to deal with aggression and bullying.

Cecile: Change the name of the class if men are actually invited to join the class? Men are probably discouraged to join the class since it actually just says Women in the title.

Parker: Only if the class was truly a co-ed class. If not add a separate one

Jemal: The class says for women but it technically is for both sexes? Why not just change the class title.

Parker: [Read resolution with an ultimate goal of making a class that is co-ed or open to men] Mohammad: Feel that a co-ed class wouldn't work. Techniques to defend class are different and would recommend support two different classes, just for women and just for men.

Parker: There are pros and cons to both and both are valid. Still think either or is fine.

Yacob: Unfair to discuss this without the person that created the class. Women are more likely to be assaulted and this is the purpose of this class.

Dean Hearn: Decide whether you want to the class to be strictly co-ed or men. Add credit course somewhere in the resolution.

Jesse: Department chair said that she would like to keep the class name and also add a men's class. Bring awareness. Support with Dean Hearn that we support just a men's class

Parker: Point of doing both would be to give people the option. Personally opinion is that the RAD program is a great program and that at some point men should be allowed to have the opportunity to learn to defend themselves as well.

Steven: Aren't taking away anything by creating this class.

Yacob: Would sit here and vote on resolutions but is pointless if no one takes action afterwards. Really need to go to the Academic Senate to get something done.

Jon: Not coming from the standpoint where "one has one, so the other needs one," equal opportunity.

Parker: Since I brought the resolution up, intention was not to have it be where if one has it the other has it too. With this resolution, take it to the academic senate and get something actually done.

#### VIII. Major Action Items (\$1,000 or greater)

8.1. Approval of funding for **A.S. Board of Directors** to donate much needed funds to the regional and state levels of the Student Senate for California Community Colleges. This includes donation to SSCCC (\$8,000) and region VII (\$2,000). (Yacob, Contingency: \$10,000.00) *Motion by Yacob, second by Jesse* 

John: Speak on behalf of SSCCC and region VII. 30 members that compose council that makes decisions on a very day basis—group that is currently in debt because you have to fly 30 people to fly to Sacramento and have the resources to have an effective meeting. Region VII cut 70% because of budget cuts and need donations from local ASOs to work. Would be the  $2^{nd}$  or  $3^{rd}$  to make a donation without a senator.

Parker: Bring up a great point. Make everything more transparent where local ASOs could have more of an input on the Student Success Task Force.

John: First concern—input on task force recommendations. Quest for transparency but always be there.

Parker: As far as the 2000 to the region, would go more towards transportation and hotel cost? Yacob: Yes and so they could be in close proximity to people that can make a true difference John: [explain SSCCC with visuals]. Process is often inefficient and has many steps. Region VII has been defunct until this year; there were 5 presidents in a span of two years. With R7, trying to rebuild. No college donated a single dollar in this year—don't believe that they deserved the donations. Need donations now to start being effective again. Region is there to help with resolutions and different things.

Jon: How much did Pasadena contribute to this and have you talked to other colleges and what is the ultimate goal?

John: \$22,000 from Pasadena. Have been reaching out to region delegates. In a whole new ballpark—if SMC donates, the rest of the colleges will be pressured into donating as well Jon: Have been to Region VII meeting, definitely for approving this major action item Michelle: How to we know about the region VII budget? Put on the website?

John: SSCCC has a person within the region that demands accountability; could put a stipulation on this donation as well. Can arrange for it to be open within the region as well. Parker: SSCCC has been doing a great job; Support this because it is moving away from

Parker: SSCCC has been doing a great job; Support this because it is moving away from funding from the chancellors office and becoming more independent. It's a lot of money put the two groups need it—meaningful expense.

Jesse: Great idea but concerned about the accountability within the region since it is not as clear as SSCCC.

John: Region VII's problem is that they haven't spent money. Have no problem showing accountability.

8.2. Approval of funding for **A.S. Board of Directors** for funding Pre-paid stand time for A.S. bikers at bike co-op Bikerowave from July 1, 2013-June 30, 2014. This includes prepaid 540 hours of stand time. (Steven, Special project: \$3,780.00).

Motion by Jemal, seconded by Erin

Steven: Didn't know about the program before this year. Pass around the list of students that have used to Bikerowave within the past year. Atmosphere of Bikerowave is incredibly open. People go in and learn how to fix their bikes themselves and helps the culture of biking at Santa Monica College. Paying for a complete year of stand time in the 2013-2014 school year—put in the budgets of next year's board. Talked to the next Director of Sustainability and she is for the program as well. This bill was supposed to be paid a year ago yet they still offered us stand time without giving us a hassle about anything—a lot of good will on their part.

Parker: The donation is for what hasn't been paid?

Steven: This would cover future expenses.

Jemal: Has gone into here before; you learn the first time and then you can go in yourself and do it with no problem. Add more publicity to the program.

Parker: Maybe add a banner to the bike area promoting this idea. Money would go to sustain stand time.

8.3. Approval of funding for **Inter Club Council** to host the bi-annual ICC Social for Spring 2013. (Erin, ICC: up to \$3,282.00)

Motioned by Jemal, Seconded by Mohammad

Erin: May 30<sup>th</sup> in Cayton. Theme is similar to the under the sea ball in the first back to the future. Table clothes won't be ready in time. Requesting to \$100 (to \$3,382.00) to the budget—this is more expensive than the fall one because we had the

Motion to change the price from \$3,282 to \$3,382.00 Jemal, seconded by Yacob.

8.4. Approval of funding for **Civic Engagement Program** for funding for a pilot program. This includes a stipend for a graduate student, stipend for a designer, 50 posters, 4 banners and half page flyers. Motion by Erin, Seconded by Faheem

Parker: Added language about pending district approval and clear evidence.
