“WHEREAS, AB 955 seeks to place the financial burden of attending community college on the individual student, while enacting a de facto privatized, fee-for-service education mode. WHEREAS, Such approaches run counter to the historic role of California’s Community Colleges in providing a baseline of affordable higher education to all. RESOLVED, The Associated Students of Santa Monica College opposes AB 955 and any other attempts to institutionalize a shift in education funding responsibility from the state to the student.” written by Parker Jean

WHEREAS, Santa Monica College does not offer in-state residence fees to all US Military Veterans. WHEREAS, AB 13 would eliminate the requirement that a student be stationed in California for more than one year immediately prior to discharge to be exempt from paying non-resident tuition at community colleges. RESOLVED, The Associated Students supports the implementation of in-state fees for all US Veterans at Santa Monica College. Jon: The clubs are self-managed

Dean Hearn: I am 99% certain as to why the district doesn't pay for the supplies.

This is really driven by the students. You can't realistically expect the district to maintain it. This is where you come in. If you wait around for them to make a decision, you'll have weeds in your garden. Go to the district and provide a faculty member to serve in Dana's capacity. The district can then fund that member.

Benny: For the last two years the district has help fund the garden.

Parker: That's a big difference.

Benny: They do provide some assistance

Parker: I thought it was around \$50,000

Jon: I see no problem funding this. If we have to step up to help the garden, I'm willing to.

Parker: The district should continue to show support, even if it isn't financially

Parker: So, it's on Venice Blvd. It is a nonprofit co-op. It is self-sustaining. The only thing you have to pay for is stand time and parts if you were to need one.

Yacob: They do it for you?

Parker: They teach you how to do it. It's usually packed and you wait and then a volunteer will come.

Yacob: What's the relationship they have with AS?

Parker: We pay for the benefits.

Yacob: I've never heard of it.

Jemal: We should put it on the website.

Steve: That's our fault.

Parker: At Bikerowave they have a sign that said that you can have free stand time

Yacob: So basically they are doing a better job than us

Parker: We need to get the word out that students can use this, I have bought my bike there. I bought it for \$80.00
