## VI. Major Action Items (\$1,000 or greater)

6.1 Approval of funding for **Associated Students Board of Directors** to fund A.S. Students Success Awards for Spring 2014. This includes 30 awards for \$100,000.00). (Inayat Issa, Student Success: \$100,000.00).

**Inayat**: Diana and I created these AS Student Success Awards. All SMC students who have a minimum of a 2.5 GPA can apply. The amounts are between 1,500 and 5,000 dollars. You can use it only for educational purposes. There will be an application process. There will be a mandatory interview process. A committee will review it. The price would be up to 100,000 because we wanted to include more awards. We wanted more students to be eligible to receive an award. Currently, it is 15 award at \$1,500 and 15 awards at \$3,000 and 5 award at \$5,000.

Kseniya: Can international students and AB540 students apply

**Inayat**: Yes. You can't apply if you're a director.

**Kseniya**: Will it start this spring?

Inayat: Yes. We already have a committee made up of five people.

Cassandra: may we consider making a smaller one?

**Inayat**: Like 500 dollars for books? The application will be up on the AS website. It will be due late March.
