### X. Discussion



10.1 Discontinuing or continuing to pay students for being part of campus committees (Inayat Issa, Budget Management).

**Inavat**: If you're a student, you should sit on the committee to make changes, not to get money.

**Dursim**: I think there should be some incentive but I'm not sure if money is the way to go.

**Cassandra**: I agree that being paid to be on a committee is redundant.

**Kyle**: I think that some people need the money. Students devote time to work with the school. When you start rewarding people with money, they start losing instrinsic value. I think the money should be like a scholarship and not paycheck.

**Michael**: I think students should be compensated for sitting on committees. First comes the interest and then comes the reward of being paid for it. It's a "Thank You."

**Inayat**: This does not compensate for having a job. The committee that meets the most is the budget committee.

**Hasun**: In the actual documentation it does say you can receive a letter of recommendation, but I don't know of anyone who has gotten one. I think we should give a scholarship for those on committees for students who best represent the AS on committees.

**Cassandra**: I agree with Hasun. We should celebrate the best people.

Michael: I know you said that 70 dollars won't go anywhere, but I know that 70 dollars is food for the week.

Dursim: I don't think money should be an incentive. I think the way we approach the students is important.

**Inayat**: There is a faculty member that feels that students should be paid for services that helps students. We shouldn't be paying students at all. I don't think you need financial aspects.

**Halie**: There are some students who are greedy about it and some needy. I think the scholarship idea is a really good idea.

Ty: Should we get paid to sit down and sit on this particular committee?

**Inayat**: I was against it. I genuinely was interested in this position. You need students who can best represent students.

**Sonali**: In your fiscal policy that students, faculty and staff should not be payed for services.

Cassandra: I would like this discussion to move forward at another time and we can talk about this and director stipends.

Kseniya: The stipend helps me a lot. Being on campus and getting some sort of income is important.
