**Matt**: This allows me to do more events and gives me more flexibility with our events. It is usually given to our activities every year.

**Cassandra**: Isn't smc everywhere, a smc alumni event? **Matt**: I am doing it in conjunction with the Alumni.

**Inayat**: In finance, we had concerns about the foundation not donating more. SMC everywhere is not included in the motion.

**Matt**: there is a separate proposal for smc everywhere. **Cassandra**: Is feed the students part of earth week?

Matt: All these events are tentative. These are suggested events. It is something AS should be

involved in. It's not planned out yet. **Cassandra**: What's the symposium?

Ty: Is it some scholarship? Where is this coming from?

Matt: It is just something I got from a discussion with Deidre Weaver.

**Sonali**: none of this has come from finance. It's all pending. He needs to submit a proposal for each activity. The allotment allows for him to spend at least 1,000 dollars per week.

**Sonali**: Feed the Students has been approved the through finance and will be your 8.7. All of these events still have to be approved.

**Inayat**: He just needs a requisition. Technically, everything here is half approved.

Sonali: the allotment is to be used for any activity that Matt can fund.

Inayat: The allotment is for him to put on more events so the money is already available.

**Ty**: We just found out that smc has 10.5 million just sitting in the bank while departments come to us and ask for funding. We have this systematic problem of departments coming here and assume we'll fund. There's money that isn't being allotted. We are advocating for this money to be spent on departments.

**Sonali**: There are certain items that cannot be funded such as food.

**Ty**: At least 2 million of this can be distributed to departments. In the board of trustess have food. They told us they have funds from the auxiliary services. There are ways to do things, they just aren't. The money is out there and it's not getting to the departments

Matt: This is not something new, this has been done prior. This will give flexibility.

Inayat: Just because a previous director has had an allotment, doesn't mean every director will get one.

Ty: The allotment is fine but we don't want it to go to fund departments.

Motion to amend to read Approval of funding for **Associated Students Board of Directors** to fund Activities Director allotment for Spring 2014. This includes \$1,000 each week for 8 weeks given that single club specific events cannot be funded from that account line items will not be used for club specific events (Matt Nicholson, Activities: \$8,000.00) by Jasmine, Second by Cassandra.

8.7 Approval of funding for **Associated Students Board of Directors** to fund Feed the Students. This includes food. (Matt Nicholson, Activities: \$8,000.00)

Matt: I had the event this Tuesday and I got positive feedback from students.

**Inayat**: They have to be AS members though, right?

Matt: I think it should be all members Inayat: Because it is AS funding.

Cassandra: Students who paid their fees have funded their food. A lot of students are AS members



but they don't know it.

**Yana**: We have an issue that there are more than 20,000 who are AS members and not all of them know they are AS members.

Ty: If they are not AS members, explain to them why they should be AS members. Matt: How about you get a commissioner to get out there and notify the students

**Cassandra**: Gladly. Send an email out before the event. I don't want to see food from big corporations; I want to find more local healthier options.

**Inayat**: This is a good way to publicize AS so make sure you know what AS is.

**Michael**: I think there should be a banner indicating that it is funded by AS and place it next to the bursars office.

Maya: I think a simple solution would be to give flyers.

Yana: A banner would be nice and AS directors and commissioners should be there giving out the food. They can also wear AS shirts.

8.8 Approval of funding for **SMC Career Services Center** to und Annual Job / Volunteer Fair. This includes Del Rey Party Rentals, Campus Kitchen breakfast, and Campus Kitchen Lunch. (Marcia Lewis, Student Success: \$2,390.28).

**Marcia**: the career services center gives two job fairs for the students every year. Last semester I partnered with AS. We had a little over 60 employers. I only allow volunteer people who actually have positions. It is something I have done since I have been here. I do this for you. I start 3-4 months ahead of time and have postponed a surgery so I can get this off the ground.

Ty: Can we have a booth for our civic engagement program.

Marcia: Yes, it is your event, I do the work. Let me know so I can make sure you have a table.

Cassandra: Thank you Marcia.

8.9 Approval of funding for **Center for Environmental and Urban Studies** to fund Earth 2014. This includes vendor incentives, buttons, rentals, reusable bags, food, entertainment, lip balm, plant centerpieces, transportation, awards for service, art supplies, stipends, flyers/posters, and t-shirts. (Genevieve Bertone, Special Projects: \$7,656.64).

**Cathleen**: I am a student's manager at CEUS. It's a whole week of events. We have a lot on the table. **Ty**: Will we have the free store?

**Cathleen**: Instead of that, we will be having Students Feeding Students. It keeps with the theme of Food. It'll teach about food waste. Every day there is an event. It'll be an educational event. They will learn about the food system.

Ty: Can we put AS banners for the events

Cathleen: Yes.

### IX. Director & Committee Reports / Student Trustee Report/ Advisor Reports

**Jasmine:** We had our first ICC meeting last week. We had about 20 clubs installed, more to come.

**Ty:** I will be calling the constitution committee next week so we can discuss changes and will be coming to the board very soon. The ASAP committee will be forming as well sometime next week. I went to the board of trustees meeting and they approved to put the oil severance act on their agenda next week. They have a meeting on the first Tuesday of every month so it will be April 1<sup>st</sup>.

**Jesse:** The students are very happy with the renovations here. The office looks great. Yesterday was the board of trustees meeting and everyone here should know that the trustee is a liaison between the board of trustee and



AS. When I first became student trustee. I went to the orientation and it was a very short orientation that lasted less than 15 minutes. Their perspective is very different from one of the AS. It is my understanding that the student trustee should have a good relationship with the board. That wasn't the case with the previous trustee. President Tsang told me my perspective and didn't make me figure it out. He brought up that my goal is not to represent the AS board but all students. I think that the AS board does represent the students very well. The last trustee was influenced too much by the board of trustees. I can tell the difference between their facts and the facts here and make decisions. May is my last month. The new student trustee may be someone like the previous trustee. We can look at updating the policies that my roles have. I can only do that with the AS support. This is something that should be worked on.

**Cassandra**: What you can do is pass down what you have come up with to the next person. That is the most concrete way. I will be sitting on the equity committee and hopefully I can plant some seeds there.

Ty: Come to the next constitution committee. The student trustee is in our constitution. We can change our bylaws.

**Jesse**: We have to address the district because it supersedes the AS constitution. I follow the district policy. The district controls my roles. We need to address it top down.

Ty: I want you to have something in writing that will go down to future trustees.

**Sonali:** Our activities calendar is booked for the month of March, May and some of April. There is a lot happening this Spring. Your general assembly is coming up and is in the LAX Marriott. I am putting on a proposal for that.

Michael: If you go, you need to spend the night since it is very difficult to commute and go.

**Sonali**: I am really appreciating the conversation we have been having. I am here to help and support your plans. I need to be informed to represent all of you appropriately.
