### IX. Major Action Items (\$1,000 or greater) [5 minutes Each]

9.1 Approval of funding for **Associated Student Board of Directors** to fund textbook purchases to EOPS and Gurdian Scholars for Fall 2014-Spring2015. This includes textbooks. (Kseniya Lyalina, Student Success: \$10,000.00).

**Kseniya**: I spoke with EOPS and guardian scholars. Most of their funding comes from the city or government. We help out a little. This year they asked for 10,000 dolars because they are going to renew the science and math books . Gurdin scholars aer for foster youth. They can get a book from the office.

Cassandra: Have you seen what these books look like? I would love to put an AS sticker on them.

Kseniya: I think they have a lot to worry about in their life.

Cassandra: Just to put a sticker so they know.

Kseniya: I will put it as a suggestion.

**Sarah:** This is for students only at the eops program?

**Kseniya**: For EOPS and gurdin. We buy books constantly because the editions change. They have to set a whole new set of books. They don't throw them away. They give books to other colleges that can use them when they have an old edition.

### Major Action Item 9.1 Approved Unanimously.

9.2 Approval of funding for **Associated Student Board of Directors** to fund Dream Act Scholarship for the Spring 2014. This includes Dream Act Scholarship. (Kseniya Lyalina, Scholarships: \$10,000.00).

**Patti De Leure:** I am a counselor in the latino center. The foundation does not get 4% of the scholarships. Last year's distribution was 6 at a thousand and 8 at 500.

Hasun: Can you give a brief summary of the scholarship?

**Patti De Leure**: AB 540 students are students who graduated from high school in the US or got a GED who are undocumented. They pay resident tution. They are limited in their financial resource. Many of our ab 540 students are active in as and are in clubs. It is very deserved I think.

**Kseniya**: the scholarship is in our book. We have the as dream act, as international, and as high school. We fund this for years. The money rolls over if they don't use it. Last year all the funds were used. *Motion to Approve by Inayat, Second by Cassandra*.

### X. Action Items

10.1 Approval for the **Associated Students Board of Directors** to take a stance on a resolution regarding the current system of Student ID Fees (Hasun Khan, Advocacy). *[10 minutes]*.

**Hasun**: We need to get Mike's testimony in.

**Mike Tuitasi**: Thank you, board. I was first approached on March 5<sup>th</sup> to address the issues with the student ID fee and I've done a lot of research so that I can address that fee today. There were a lot of questions about the fee. That it was linked to the A.S. fee was one question, that you can't opt out of one without the other, and that the admissions office was following different guidelines was a concern. I'm glad to say they're not linked. This statement will be posted on the website. They are no longer attached so you can get refunded. We are looking at the fee with the big blue bus. The bbb wants to ensure that all students are currently enrolled. For students that wish to ride the bbb, they need to show verification which is the student id card. It will be called the student ID fee. All students need to know that both of these fees are optional. By making that change is a huge step forward to providing clarification for students in the future.

**Kyle**: The school is required to provide transportation.

Tuitasi: No, they are not.

**Cassandra**: To have an active card, what fee must a student pay to ride the big blue bus?

Tuitasi: You would need to have an active id card and the AS fee.

**Inayat**: You still have to pay the 13 dollars to ride the big blue bus. I though that's what we were fighting for. Can you pay for the activation itself but not the whole id because the funds will go to the general fund?

**Tuitasi**: To show immediate verification. The Big Blue Bus does not want to see a piece of paper of your classes. Verification to show you are enrolled, we show it with the swipe.

**Ty**: Why do students need to pay a fee to show they are enrolled rather than have their card activated when they pay the tuition?

Tuitasi: You student id card is used for that.

Hasun: In other colleges, students can ride the bus for free and not pay the id fee.

**Tuitasi**: You ride one hundred percent for free. At ucla, you pay fifty cents per ride.

Motion to Extend Time by Five Minutes by Inayat, Second by Maya.

Extension Approved Unanimously.

Inayat: Why can't we just charge students how much it costs to actually activate the card because the



13 dollars is not to pay for the activation? The 13 dollars are used elsewhere.

**Tuitasi**: You're asking a hypothetical question, I can't answer it. **Hasun**: How much does it currently cost to activate the card.

**Tuitasi**: This is a question for someone else. **Hasun**: This is for question directed in budget?

**Tuitasi**: I was asked to answer questions. I'm not here to answer questions.

**Hasun:** Where does the money go? **Tuitasi:** It goes to the general fund.

**Jasmine**: I would like to make a request to see if we can make the cost of the id separately. I think that we are forcing students to but the whole id fee.

Motion to postpone 10.1 until next week by Cassandra, Second by Inayat.

#### XI. Discussion Items

11.1 Screening the 2014 World Cup Games in the Cayton Center (Ty Moura, AS President). [10 minutes].

**Ty**: Do you think we can install a system in here so we can show games. Brazil is always four hours ahead so in the afternoon early evening.

**Cyrus**: Everyday? **Tv**: Yes for June.

Maya: We should consider just doing it in the cafeteria. This is a school experience.

Hasun: Can we have a viewing outside?

**Sonali**: Unless it's activity hour, we can't have amplified sound. If you wanted to show a game in the room with sound, you can be able to do that with compromise. We should consider putting a projector in here and getting a tv.

**Sarah**: I like the idea of having limited hours. Like maybe later in the day when classes are usually over.

**Cassandra**: I just looked up the schedule for the world cup. There's a few that conflict with finals. I think we should hold these in the evenings.

**Halie**: I want to help the next director of sustainability. I have also been in contact with convergence coordinators and I hope to bring a convergence here.
