8.1 Approval of funding for **Associated Students Board of Directors** to purchase items for Summer 2014 and first month of Fall 2014. This includes scantrons, blue books, emergency funds, staples, Brinks Armor truck PO for 1 year of A.S. funds, activities for first weeks of fall, and Cayton Lab supplies and maintenance. (Sonali Bridges, Office: \$6,710.00, Activities: \$2,000.00, and Cayton Center: \$22,332.25, Total: \$31,042.25).

**Sonali**: This item is to keep the office running while you are not here. The new board won't be here to go through the new proposal process in the first two weeks.

**Jasmine**: Would we be able to add getting a few lights in the cayton lab?

Ty: It will be in the renovation which we will approve soon.

**Kyle**: With the truck, do we really need an armored truck?

Amelia: 19.50 times 20,000 student is a lot.

Ty: Why are we paying for an entire year?

Amelia: The process goes for the whole year.

**Sonali**: This is an open PO. The pick-up and drop off every year.

Ty: How much are we paying, how much are they paying?

Sonali: George would have to answer that.

**Inayat**: We are paying 1,710.

**Sonali**: This is for our contract. The departments have a separate contract.

**Kseniya**: There are four scholarships under our name. This year we only have 24,000 left in the account and that's the maximum we can.

Ty: This is part of the scholarship book.

**Kyle**: Do you publicize the scholarships through any organizations?

**Marcia**: Every student services centers have brochures. We have a massive media about scholarships. Go online, that's important.

Ty: Is this for this year or next year?

**Marcia**: Every year we have to solicit funds. The AS Dream scholarship is for AB 540 students. We have the AS high school scholarship which helps recruit them.

**Ty**: Would it be possible to still add that stipulation? Would it be possible to let them know when they are given the check, it is expected for them to come to the AS office.

**Cassandra**: The can see a free opera show, that's culture right there. It seems as though since we are donating that we would reach platinum circles of donations. We can have a sneak peak by attending the final rehearsal. It looks good and it'll be fun. It'll be a good opportunity for student.

**Inayat**: The cost of these tickets.

Julio: the tickets would be given to you guys. Everything will be free so student can attend.

**Inayat**: This cost is covering the production, not the tickers.

Julio: We have to pay to use the broad stage.

**Inayat**: No items will be considered to be given to donation.

Ty: If someone wants to donate something to the students, they should do it directly.

**Julio**: We are trying to give back to the students a free performance.

**Jasmine**: These tickets are all for students? The website says that it's 15 for students.

Julio: This is to cover the costs. It is for all the students.

**Dersim:** We have to amend so it doesn't say that it's for tickets.

**Inayat:** the money can't go for tickets. We need to change the language to say to cover production costs.

Julio: I spoke to someone who told me to change to tickers.

**Inayat**: I think that was a miscommunication.

Amend language to read "Approval of funding for Music Department to purchase materials for an

**Julio**: There will be four performances, only one will be exclusively for students. The other performances are for other professionals who get paid. It is funding production costs.

Ty: You can't use the costumes they used the previous night?

**Julio**: They are rented.

**Professor**: We have three performances scheduled. The students wanted to do this, just for the students. This one will be exclusively students.

**Jasmine**: Is this for all students or as members?

Cassandra: That's for us to decide.

**Professor**: We have some grant money. **Julio**: We are reaching out to businesses.

Julio: All production costs.

8.4 Approval of funding for **Associated Students Board of Directors** to purchase a TV for A.S. meeting room. This includes Samsung 55" and tax. (Sasha Mirabi, Office: \$2,729.99).

**Inayat**: Are we purchasing the TV just for the world cup?

**Jasmine:** We didn't include costs for mounting it. I just bought a 51 inch for 750. I can find you a quote for something that is cheaper.

Ty: If you think you can find one that is cheaper, you can amend the cost.

Ty: We have an antenna cable.

Maya: I don't see a need for the TV at all if we are using the projector system.

Dean Bridges: We contacted the media department and we are not getting much support for that.

There is a lot of events you host up here and it can be used for all of those purposes.

**Inayat**: Instead of putting the TV in the conference room, can we put it in here?

Ty: We can move to the TV.

Cyrus: We want to use it for videos; we need it in the conference room.

Benny: The one we had before you could roll it in and out.

Dean Bridges: You can move the white board and have it on the wall.

**Jasmine:** I printed out quotes, it's 50 inches and a smart TV. It's on sale for 877. I also included quotes for installation. I printed out a quote for a tuner. The total cost should be 2,000.

**Hasun**: This is an extension of our last resolution. I will be taking it to DPAC, if approved. I'm open to questions.

Cassandra: Most times our students pay online, is this addressing that?

**Hasun:** When we verify our cards, it doesn't have to be swiped, it's the sticker you need. This is a request item. Administration has been negating it but it should be feasible.

Ty: It requests the student ID to be activated upon enrollment. If you prove you paid your enrollment, it should be activated.

**Kyle**: With the five dollars which is the cost of the copy, is that the actual costs for the card?

**Hasun**: We are diminishing the cost. I have questioned the costs to DPAC budget about the actual plastic. I want to bring us in compliance with student handbook.

Dersim: Does enrollment fees include the AS fees.

**Hasun**: The language should read that "proof of payment of enrollment fees" *amendment passes*.

Ty: We shouldn't add the AS membership fee since it has nothing to do with this.

**Dersim**: When you activate the card, it for the bus so it should be mentioned here.

Hasun: We can add "and administered upon proof of payment of AS fees"

**Kyle:** With paying the five dollars per semester, I don't know if that is right in the student ID handbook. We are getting a proof of enrollment.

**Hasun**: The cost that you're seeing is your proof of enrollment, not the ID fee. Right now, we are charging way too much and it's not fair to students.
