## VII. Major Action Items (over \$1,000)

7.1 Approval of funding for the CA Student Sustainability Coalition Conference. This includes conference registration, transportation, hotel, & meals. (*Andrea Gonzalez, Sustainability*, \$8,786.00) (*Note: This item did not go through Finance & are being reviewed by the AS Board due to time constraints.*)

Added to the agenda as an emergency item for only 25 students, it was given back late. Student led conference and it will take place on the 14<sup>th</sup>. The theme of the convergence is "take action", not only about sustainability but also about classes, fracking, and more. Suggested bus as transportation, but a bus is only for 22 students and they are trying to take 30. Pro con debate: Director of Community Relations asked about an agenda, Director of Sustainability replied that there is an agenda posted online that she can share with us. Vice president asked are the students contributing any money as part of the trip. Director of Sustainability replied that no, that the money is coming out of her line item. The President requested that when they return that they make a public comment about what they learned Director of Sustainability also says that they will be taking pictures.
