This section of the agenda is reserved for members of the public to address the Inter-Club Council. A time limit of 2 minutes per speaker shall be observed.


ICC meeting to get more people involved by adding food, for more participation.

## IV. ACTION ITEMS

## 2.1 Discuss and approve changes to Election Code.

**Counselor/PT Advisor: Jeff Gordon:** Point of information after the meeting when there was a date change. In order for it to be discuss there must be a motion for consideration.

President motion to reconsider the dates second by ICC communication officer.





The language stating on the election code. Concern is that there is a 10-day period where there might be campaigning going on. The code has nothing stating of the free for all campaign (soft or hard campaigning). Since there a lot of clubs not yet installed, worried about the number of people who will start campaigning early. Having the 10-day period to not campaign.

**A.S President: Jennifer Chen:** Move it a week before everything, so campaigners can have time to campaign with material being ready.

Ex: "I had the mandatory candidate meeting on Thursday and could not start campaigning because it was Friday. I have not yet received my campaigning materials."

**Counselor/ICC Advisor: Benny Blaydes**: Student cannot automatically get disqualified, due to Dupo process. The students can only be subject to campaign violation.


**Counselor/PT Advisor: Jeff Gordon:** Original date march 26<sup>th</sup> (campaign) notified them by the 23<sup>rd</sup> given them three days for material to be approved.

**Club Officer 2: Niayesh Mousakhani:** Original March 14, 15, 16 move it to 12,13,14, it going to change by two days. Given three-day period period to go over campaign material.

**Counselor/PT Advisor: Jeff Gordon:** 1<sup>st</sup> ICC meeting for Spring semester is on Feb 22<sup>nd</sup>. The second is on the March 8<sup>th</sup>. If the person wanted to start running, they will need a club officer. To be a club officer the club needs to be installed first.

**A.S President: Jennifer Chen:** Point of information: Come in sign off then turn in packet. Attending the meeting.

**Counselor/ICC Advisor: Benny Blaydes**; Major disadvantage when the students are not directors, putting new people at a disadvantage. Trying to make it fair for those who are not





associate with the A.S board.

**Counselor/PT Advisor: Jeff Gordon;** Point of Information, originally opposed or amended new dates. Original dates Feb. 12 – due by the Feb 16<sup>th</sup> meeting March 14.15.16 due review for review the 20<sup>th</sup> by 6pm, notified 23<sup>rd</sup> no later. That's does not mean they cannot turn it in earlier.


**A.S President: Jennifer Chen:** People should come in more prepare student will be having one month to submit packets and in one week teaching them what is going on in a campaign. **Counselor/ICC Advisor: Benny Blaydes**: Last few years' people students have no clue in the process and one week is not enough. The later people have the process the fairer. We don't have the best publicity as a commuter school and it is hard to advertise campaigning or open positions. People are not always on campus sometimes they are in school once or twice a week.

**ICC Communication Officer**: This gives the student option to reschedule everything. In my position I needed to figure out my schedule. Giving me one –two weeks, so I can fix my schedule. There is people who are not in the circle, I had to figure what my position was about before running to get in the circle. Giving students a month will be an advantage for everyone.

Motion by the President to change the packets to be available on February 12<sup>th</sup> and the candidates mandatory meeting will be on March 14<sup>th</sup>, 15<sup>th</sup>, and 16<sup>th</sup>. Campaign packet due on March 16<sup>th</sup>. Due review will be on March 20<sup>th</sup> and the campaign will start on March 26<sup>th</sup>. Second by ICC Communication Officer with no objections.

Motion by the ICC chair to increase the amount of reimbursement by \$125 with no objection.





#### 2.2 Discuss and add rules for social media use.

**Counselor/PT Advisor: Jeff Gordon;** The only ones being able to file a complaint is a worker or a someone in the election committee. If someone slanders on their own personal page is different than a public page. We cannot see their personal page compares to their campaign page. Spring court for A.S is important committee which is the Constitution Board.

**Counselor/ICC Advisor: Benny Blaydes**; Social media should follow the guideline on election code on page 7<sup>th</sup> and 8<sup>th</sup>. The dean and the chair will only to figure out the consequences who consistently does not follow the rules. Anyone who violates page 7 and 8 is subject to disqualification. Deans and chair will have the determination for the student's violation.

No objection to Counselor/PT Advisor: Jeff Gordon proposing publicity and social media Item 2.2 on the Election Code.


## 2.3 Discuss and add section on consequences for code violations.

**2.5** Discuss and add section on sustainable campaigning.

Club Officer 2: Niayesh Mousakhani; Suggestion to add the section on page 7 number 5 on election code. "Clubs may decide and may let none or all of the candidates to promote themselves at their clubs regardless of the relationship with the club officers. Clubs are not allowed to discriminate between the candidates and any violation to this will be subject to consequences."

**A.S President: Jennifer Chen**; Electronics and stakes are convenient instead of business cards because business card is not sustainable. Each class can have a poster and when campaigner talk about themselves they will have the poster. Suggesting to put everyone face on who is running on bulleting so there is not many paper being misused.

**Counselor/PT Advisor: Jeff Gordon:** Point of suggestion to limit the amount of business cards. Four-ups were used back then and was able to save paper that way. 220 four-up to limit them.

**ICC Chair: Kyana Shajari:** Suggesting to put A.S logo on business card so there will not be more business cards produce.
