

Guaranteed Transfer Admission Agreement between Santa Monica College and California State University, Chico for International Students

(<u>Impacted majors</u> are <u>not</u> covered under this agreement)

In order to benefit both California State University, Chico (Chico State) and Santa Monica College (SMC), in the recruitment and retention of international students in their educational planning and the completion of a bachelor's degree, Chico State and SMC commit to maintain and enhance relations between our institutions with regard to facilitating a smooth transition and guaranteed admission into a non-impacted major for all qualified* SMC international students.

Chico State defines a qualified SMC international student as one who has:

- ✓ An F-1 visa.
- ✓ Good standing at the college.
- ✓ Completed at least 24 semester units with a grade point average of 2.0 in all transferable college coursework.
- ✓ Completed the required coursework in three fundamental areas of General Education with a grade of C or better students must choose one in each category (A1, A2, B4) listed below.
- ✓ Submitted a Chico State application for admission by the application deadline (www2.calstate.edu/apply/international).
- ✓ Submitted official transcripts from all colleges attended.
- ✓ Submitted official secondary school transcripts (if transferring with fewer than 60 transferable credits)
- ✓ Demonstrated proof of financial ability to pay for all costs of attending Chico State for the first year.

Santa Monica College

- ➤ A1: One of the following COM ST 11, 12, 16, 21
- > A2: One of the following ENGL 1 or ID
- B4: One of the following MATH 2, 3, 4, 7, 8, 10, 11, 13, 15, 21, 26, 28, 29, 54; ACCTG/BUS 45 (completed Fall 2018 or later)

*The qualifications for guaranteed admission to Chico State (listed above) reflect international admission requirements for the current academic year. In the event that Chico State's admission requirements change, future SMC applications to Chico State will also be guaranteed admission if they meet all admission requirements for their admission term. Current admission requirements are detailed at: https://www.csuchico.edu/international/qualifications/index.shtml.

Furthermore:

- SMC will inform prospective international students of this partnership.
- SMC will share information about this agreement with the international student counseling center.
- SMC agrees to include information about this partnership as well as a link to Chico State on their website.



This collaboration will be in effect for five years from the date of signing. Either SMC or Chico State can terminate this agreement at any time by providing a six (6) months advanced notice to the other Party.
